This is in reference to my recent visit to Jaipur and Jhalawad(5/04/2018 and 7/04/2018) regarding land allotment for Venkys Poultry Project in Jhalawad district and our meeting to your good self.

Sir, there is an amendment in land requirement due to provision of 1958 act for allotment of land for poultry, dairy and Piggery in which it is clearly mentioned that such allotment should be 1 KM away from village awadi. 1. First land is between Bhawani Mandi –Dug highway to Dhatooriya road. This is on the left side when we are moving towards Dhatooriya village. Khasra No -831, Village –Dhatooriya, Tehsil-Gangdhar, Khasara

Distt-Jhalawad. We need 40 acre Land from this khasra no.

Important consideration that Land must be 0.5 KM away from Village.

2. Second Land is between Village - Dhatooriya and Village -Kabiri on right side when we are moving to Kabiri.

Khasra No-722/36 Village -Dhatooriya Tehsil -Gangdhar, Distt-Jhalawad. We will required 50 acre land here.

Kindly allot above land pieces to M/s Venkys India Limited for development of poultry project at the earliest.

We will send our Project Team to verify the land pieces for allotment. Land records are enclosed. Hoping an early action.
